## Effective legal drafting

#### What's it about?

Clients expect their law firms (and businesses expect their internal legal teams) to deliver high-quality agreements on ever-tighter budgets. As a former dispute resolution partner in a global law firm, Cathy understands the importance of managing legal risk by drafting clearly, succinctly and unambiguously. She developed this course after analysing the skills needed to be an excellent transactional drafter. You'll learn how to draft confidently and flexibly to create user-friendly agreements that achieve their objectives.

#### What does it cover?

The course is flexible in length and scope. The full course is four modules, ideally attended in order, but we can tailor it to your organisation's needs. Modules 1 and 3 are most suitable for more junior lawyers. Modules 2 and 4 are suitable for all. We like, where possible, to reinforce your house style. There are practical exercises throughout, taken from real agreements, to stretch delegates and to embed the learning.

#### Module 2 – User-friendly drafting

  - Choose the active voice.
  - Keep your sentences short, particularly by dividing into sub-clauses.
  - o Don't use a long word if there's a shorter one that means the same.
  - o Don't use three words if one would do.
  - Avoid (or explain) jargon, including legal jargon and the word "shall"
  - Don't turn verbs into nouns.

## Module 3 – Drafting confidently "from scratch" and using precedents wisely

- Using a four-stage approach to draft clauses or whole agreements when there's no template or precedent
- Some pitfalls with precedents and templates
- Making best use of precedents and templates

### Module 4 – "White-water drafting"

- Language that causes more than its fair share of disputes
- Drafting flexibly to reduce legal risk
- Quiz on standard "boilerplate" language clarifying the English legal meaning of some common legal words and phrases
